



Economic Operators Registration & Identification Numbers

What is an EORI number?

- All economic operators (EO) including Freight Forwarders and NVOCCs engaged in Customs-related activities within the EU are required to register with an EU Member State for an EORI number.
- The EORI number is a common number to be used in Customs-related activities throughout the EU, unique to each economic operator.
- EORI numbers are required to be entered when making Entry Summary Declarations (ENS) and other related Customs activities.

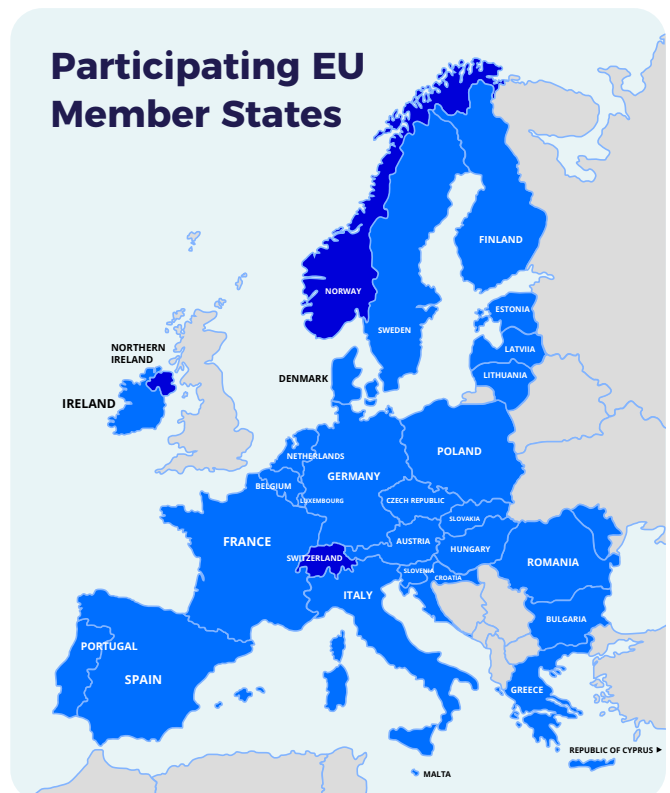


Who needs an EORI number?

'Economic Operators' - individuals and companies engaged in Customs-related activities in the EU - (ie: Consignor, Consignee, Buyer or Seller) need to register under the Economic Operators Registration and Identification system and be assigned a unique EORI number.

- To obtain an EORI number, an Economic Operator must be a 'person' (natural person, legal or association of persons) as defined by Customs code and specified by law in each member state and must carry out activities covered by Customs legislation within the EU.
- EOs established in the European Union (EU) should obtain their EORI number from the EU member state where the company is established.
- EOs based outside the EU should register in the EU state to which they ship freight most frequently.

How do I register for an EORI number?

If you need to register for an EORI number:

- If based in an EU member state, apply in your country of residence / incorporation.
- If based outside the EU, apply in the EU state where you ship freight most frequently.
